Important Instructions for Candidates

1. Candidates should verify the fee structure of Private/Minority colleges on the respective college website and the FRA (Fee Regulatory Authority) website before filling in their choices/preferences.
2. Candidates who have been allotted a seat in Round 1 or any subsequent CAP round and wish to seek betterment must first report to the allotted college and complete the admission process.
3. Candidates who want betterment should not fill the "Status Retention Form". Once Status Retention Form filled it cannot be reverted.

4. If a candidate fails to report and join the allotted college within the prescribed time period, they will not be eligible for any further CAP rounds. Such candidate will be eligible only for Institute level round.
5. Candidates must fill in their choices/preferences separately for each subsequent round.
6. If any candidate is satisfied with the allotment and wants to confirm the admission, they should fill out the Status Retention Form. The college shall not force any candidate to fill Status Retention Form.
